THE HIGHEST POTENTIAL OF SPORTS IS ACHIEVED WHEN COMPETITION REFLECTS THESE SIX (6) PILLARS.*

*USE ALCOHOL, DRUGS OR SMOKE WITHIN THE VICINITY OF THE PLAYING FIELD*

*COACH MY CHILD FROM THE BLEACHERS, I UNDERSTAND THAT THEIR COACHES GIVE OF THEIR TIME AND IF I CHOOSE I CAN BECOME ACTIVE AND VOLUNTEER*

*LEAVE MY CHILD UNATTENDED WITHOUT NOTIFYING THE COACH*

## CONDUCT SUBJECT TO DISCIPLINE

- Pounding or climbing fence
- Defacing or damaging property belonging to any individual, team, association or field
- Being involved in any activity that would warrant the summoning of law enforcement
- Inciting any person(s) to become involved in any of the above listed behaviors

## DISCIPLINARY ACTION FOR VIOLATIONS OF THE CODE OF CONDUCT (PLAYERS)

1. VERBAL WARNING FROM RECREATION DIRECTORS OFFICE
2. WRITTEN WARNING FROM RECREATION DIRECTORS OFFICE
3. GAME SUSPENSION REGISTRANT MUST ATTEND GAME SUSPENDED FOR (IN FULL UNIFORM IF APPLICABLE)
4. THREE (3) GAME SUSPENSION
5. REMOVAL FROM TEAM
